This report presents findings of the evaluation of the Crisis Intervention Team (CIT) program in Jackson County, Missouri. The report includes three sections: 1) Program milestones, 2) Five year CIT incident trends, and 3) 2015 CIT incident data by departments.


Program Milestones. Some highlights of the 2015 CIT program included:

- KCPD CIT Squad formed in February 2015 and is housed at Metro Patrol
- Four basic trainings were conducted. The trainings were attended by 239 law enforcement officers, mental health professionals, and advocates.
- The Annual CIT Consumer Picnic was held at Swope Park. Law Enforcement volunteered at the picnic to increase positive relationships between consumers and officers.
- A cohort of MACITC members attended the First Annual Missouri State CIT Conference in Columbia, MO.
- Telecommunications CIT Training was held twice in 2015. A total of 139 telecommunication professionals attended the training. This was a new training for the MACITC in 2015.

Threat Assessment. The 2015 data represents the third year in a row that a decrease in suicidal behaviors was found.

Disposition. Across years, the most common disposition for all departments was *Evaluation*, which refers to a mental health evaluation performed by a qualified mental health professional.
